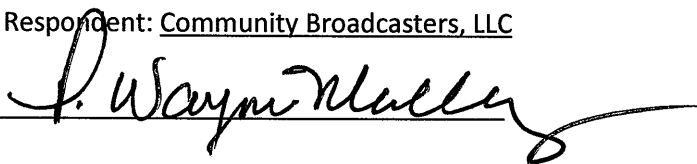
During the last 12 months, the station employment unit engaged in the following initiatives:
